<sup>1</sup> Subject to the member meeting the club's payment schedule, whenever possible charter members are reassigned to the same slips assigned to them the previous season. Slips are assigned based on matching boat length and beam with slip size and on a first-come, first-served basis, as determined by the Dock Master. The Dock Master has the responsibility to re-assign slips at any time if deemed necessary to accommodate club membership. New applicants who cannot be accommodated with a slip assignment will receive a refund.

## SIGNATURE AND DATE

I understand, acknowledge and certify that:

I have read, understand, and agree to abide by the Perry Yacht Club (PYC) Bylaws and the Policies of the PYC Board of Governors. I understand the above dues requirements and agree to pay promptly all dues and assessments and understand that should I fail to do so, the Board of Governors may revoke my membership.

Leased Slip Rights members are required to pay a \$150 non-refundable reservation fee by February 1 of the current year, which will be applied to their total annual membership dues. A Leased Slip Rights member whose total annual dues are unpaid by March 1 of the current year will relinquish Perry Yacht Club membership and their slip will be reassigned to the "open for lease" status.

I, the undersigned member of Perry Yacht Club ("PYC"), understand and expressly acknowledge that access to and use of the PYC facilities, grounds, storage areas, docks, ramps, boats and equipment, and attendance at or participation in PYC sponsored events, may be dangerous and pose serious hazards which may result in my injury or death, the injury or death of my family members or guests, as well as damage to my personal property. I expressly acknowledge and agree that my access to and use of PYC facilities, grounds, storage areas, docks, ramps, boats and equipment, and my attendance at or participation in PYC sponsored events, will be at my own risk. As a condition of my membership, on behalf of myself and my family, estate, heirs and assigns, I hereby waive and release and forever discharge PYC, and its Board of Governors, members, employees, officers, agents and volunteers, from any and all claims, lawsuits or causes of action (of any kind or nature whatsoever) arising from my access to and/or use of PYC facilities, grounds, storage areas, docks, ramps, boats and equipment, and/or my attendance at or participation in PYC sponsored events (including, but not limited to, claims arising from death or bodily injury or property damage).

I expressly agree that in the event that any membership dues or fees owed by me to Perry Yacht Club are more than one year past due, Perry Yacht Club will have a lien on all personal property owned by me and stored on the Perry Yacht Club grounds or in slips, including, but not limited to, any and all boats, cradles and trailers. I further acknowledge and agree that in such event, Perry Yacht Club may exercise its rights with respect to the lien and sell such property. If a sale takes place, then any remaining proceeds of the sale will be deposited with the Kansas State Treasurer within one year of the sale, after offsetting all amounts owed and all costs and expense related to the sale.

Because the Club is a "not-for-profit" organization, your on-time remittance of annual dues will allow the Board of Governors to schedule needed improvements and contract for necessary work, and will be greatly appreciated.

Perry Yacht Club is owned and operated by you, its members. Each member is encouraged to generously apply your talents within those areas of personal expertise and interest to help generate the dynamics that have been a hallmark for the Club's past successes.
